VENICE SHORES COMMUNICATIONS TO RESIDENTS

Venice Shores has occasion to communicate with the residents of the community at various times during the year and for various reasons. As you know, the newsletter is published three times per year and flyers announcing upcoming events are often placed in your paper boxes or attached to your mailbox flag. During the June board meeting, it was suggested that all *unofficial business* communications always be printed on the same color paper so that VSPOA residents can easily identify news from Venice Shores. This is a great idea and one that all committees are adopting—beginning with the Spring/Summer edition of the VSPOA Newsletter! Beige paper prints well with black ink and is now the official color of VS news for the Venice Shores resident. Keep a lookout for future communications—just look for the beige paper! And while we're on the subject of flyers, be advised that nothing can be placed directly in your mailbox unless it is official USPS business. Using mailboxes for any other reason is a violation of Federal Law. Existing residential mailbox laws state that only authorized letter carriers may insert mail into a residential mailbox. For this reason, if your property has 1) an open-backed paper box, or 2) no paper box, or 3) no mail pick-up flag, then you may not receive drop off flyers. We try our best to make sure each resident knows about upcoming events, but since we cannot use your mailbox, we sometimes have no choice but to skip your property. Thanks in advance for your understanding.

NEW NEIGHBORHOOD WATCH SIGNS

Have you seen the newest addition to the neighborhood? Both entrances—Bayhaven and Clairpointe—plus most canals, now feature a Neighborhood Watch sign. The signs state "All suspicious ac-


