Ohalloran's Public House was \$6500 for 150 people and they can handle up to 190. A motion was made by Kevin Paton to budget for the party not to exceed \$5,000. Seconded by Doug Pollum, the motion carried.

### **OLD BUSINESS**

- 1. The legal committee interviewed the suggested law firm of Zelmanski, Danner & Fioritto to act as our new attorney. They were impressed with their experience and capabilities. A motion was made by Mark Wright and seconded by Kevin Paton to retain Zelmanski, Danner & Fioritto for our future legal needs. The motion passed unanimously.
- 2. A motion was made by James Faircloth and seconded by Bryan Pollum to budget money not to exceed \$2,000 to have our new lawyer review our deed restrictions and make suggestions on how to modernize them and present the changes in a manner that would have a high likelihood of passage. The morion passed unanimously.

#### **NEW BUSINESS**

- 1. A letter of resignation was received and accepted from Jessica Swanson.
- 2. Andrew McKinnon was nominated to replace Board Member Jessica Swanson by Al Doss and seconded by Jim Wietcha. The motion carried.
- 3. A proposed budget was presented by James Wietcha that leaves the dues amount unchanged. A heated discussion ensued regarding a new budget item for road maintenance. No agreement was reached and the budget discussion was tabled until next month's meeting.

### **ADJOURNMENT**

The mosquitos prompted a motion to adjourn by James Faircloth and seconded by Dave Aldridge. The meeting was adjourned at 8:10
